**Agreement to Rent** - SATELLITE PHONE SOURCE agrees to rent to Customer the phones, and all accessories as agreed in this Agreement. The Term of this Agreement is determined from the dates the customer first receives the phone and ends when SATELLITE PHONE SOURCE, LLC receives such equipment back in full, with allowed grace period. It is the Customers responsibility to understand how to use the equipment and to verify that it is operable. Should the customer not return the phone to Satellite Phone Source or notify them of problems upon receiving the phone, it is deemed operable, and the customer agrees to be responsible for all charges set forth in this rental agreement.

Customer shall pay all cost including, without limitation, court cost, attorney fees, the fees of any collection agency and any other costs incurred by Satellite Phone Source, LLC in exercising or defending any term of, or right under, this Agreement. Customer agrees that the laws of the State of Tennessee, without regard to its conflicts or choice of law shall govern this contract, and that sole venue shall be Columbia, Maury County, Tennessee, and USA.

**Airtime Charges** – No daily minimum of usage is required, you pay for what you use. There are no refunds for unused bundled minutes. In the event you use more than your pre-pay bundle your rate will revert to the basic rate for your phone \$1.75 per minute for Iridium and \$1.55 per minute for Globalstar. Iridium basic rates of \$1.75 per minute apply for voice calls to Public Switched Telephone Numbers, Inbound calls via Two-Stage Dialing, All data calls and Outbound SMS messages.

Globalstar rates and Pre-Pay minutes are based on calls originating in the USA and parts of the Caribbean, and do not cover long distance calls to countries other than the US, Puerto Rico, or Canada as shown on Globalstar website map. Roaming refers to all calls originating outside the Home Service Area, and is indicated on the LCD screen of the Globalstar phone. Roaming is \$3.49 per minute and applies to calls made while phone is outside of the Home Service Area both for inbound and outbound calls. Calls made to an Inmarsat terminal will be billed at \$11.00 per minute.

**Rental Charges** - Customer agrees to the rental of all equipment, shipping/handling, airtime and taxes incurred from the rental and use of the equipment and services in this Agreement. Charges will continue at a rate as specified per day on all equipment not returned by the date on page 1 of this Agreement. If any equipment is found to be damaged when returned; then such equipment would be charged to customer at replacement retail value. Before Shipment, Satellite Phone Source, will make an immediate charge to the named account for the rental reserve period. Satellite phone Source reserves the right to put a hold on the Customers credit or debit card to cover the retail value of the equipment at any time during the rental period. The listed prices of the charges do not include sales, usage, excise, ad valorem, property, or any other taxes or fees now or hereafter imposed directly or indirectly, by any governmental authority or agency with respect to the Service. Customer shall be responsible for the payment of any applicable taxes or fees, including but not limited to any Universal Service Fund charges.

The implied warranties of merchantability and fitness for any particular purpose are hereby disclaimed and excluded. Satellite phone Source shall not be liable to its customer or any third party for any special, incidental, or consequential damages or loss of use or profits or revenue, nor for injuries, including death.

**Limitation of Liability** - In no event will SATELLITE PHONE SOURCE, LLC, be liable to the Customer for any incident, indirect or consequential damages however caused, whether by SATELLITE PHONE SOURCE, LLC, negligence or otherwise.
